- **Sympathy:** While bathing in the Tamsa one day, Rishi Valmiki witnessed a heart-wrenching scene of a pardhi mercilessly slaying a saras. Seeing this, a verse was spoken from the mouth of Rishi Valmiki.

He formed a sloka in anushtup verse from his mouth and composed the Ramayana.
